disciplinary Conceptual Fine Artist, Craftsperson, Reiki Master Teacher and licensed Non-denominational Minister,

Services are rendered at 1UV Gallery Studio located at 2959 Park Avenue, Suite D, Soquel, CA 95073. Services are
rendered at a price of \$200 USD per hour with a 1 hour service minimum per appointment. Appointment length may be
scheduled up to a maximum of three hours. Appointments must be made a minimum of two days in advance and must
be paid in full at the time of securing the reservation. Payment is accepted via credit card or cash. A secure payment
link will be provided via email or text message OR payment may be made in person at 1UV Gallery Studio. Once
payment is received a confirmation email will be provided to the client via email. Refunds will only be issued if Larissa
must cancel the appointment, or if verifiable extenuating circumstances arise for the client, and then ONLY at the
discretion of Larissa. Each appointment may be rescheduled once with no penalty up to 24 hours in advance.
Appointments rescheduled more than once will be subject to an additional charge of 50% of the regular appointment fee
to be paid when services are rendered.

Stand alone appointments for Spiritual Consultation services may include one or any combination of the following: Tarot
reading, Intuitive reading, Chakra balancing, Reiki (excluding Reiki training), guided meditation, personal coaching,
smudging, channeling, and/or stone assessment. Appointments require no specific religious affiliation of the client.

Recurring appointments may include any of the above as well as suggested texts to read, journaling exercises, and/or
meditation.

Spiritual Consultation does NOT include or require the removal of clothing. If Reiki is used during a scheduled
appointment the client will be asked to temporarily remove jewelry, metal belt buckles, and shoes. Reiki only uses
physical touch at the comfort of the client and discretion of Larissa.

Larissa is not a licensed medical professional. She does not make medical diagnosis or prescribe substances. The client assumes all personal responsibility for seeking medical advice in the case of illness.

Larissa is not a lawyer. She does not provide legal advice. The client assumes all personal responsibility for seeking legal advice in the case of legal concerns.

Larissa is not a therapist. Consultation is not therapy and can not be submitted to insurance. Consultation is 100% voluntary and for the purposes of: relaxation, personal growth, and Spiritual exploration only.

Spiritual Consultation is confidential. Larissa keeps written records of appointments. Digital copies of records may be provided to the client via email within 14 calendar days of written request. Written request may be made via email to larissa@1uvgallerystudio.com. Records will only be released to third parties with written permission of the client or official court order. Larissa reserves the right to share information without client consent or notification with law enforcement ONLY in the case of reasonable concern of imminent self harm or danger to others.

Recording of any kind is prohibited during appointments. The client agrees to turn off all digital devices before receiving services. The client is encouraged to take written notes. If the client does not have a designated journal with them at the time of their appointment, Larissa will provide a notebook and writing utensil for the client's exclusive use. Confidentiality is not mutually exclusive between Larissa and the client. The client may share the content and experience of their Spiritual Consultation from Larissa with any party they so choose at any time.

Appointments for Spiritual Consultation are private (one on one) and may only be reserved by persons 18 years of age or older. Couples may attend an appointment jointly if each adult pays the hourly fee. Each person in the couple must sign a separate agreement. Licensed personal nursing assistants may attend appointments with the client for the purpose of the client's medical need at no extra charge. Appointments may be made for children under the age of 18 (and/or pets) by a parent or legal guardian IF the parent or legal guardian is present for the appointment.

The client agrees to park only in spots NOT marked as reserved for neighboring businesses.

Clients arriving more than 15 minutes late for their appointment forfeit their appointment and fee and must reschedule at regular price. Arriving late more than three times will result in no more appointments accepted.

Point of sale presentation of products on exhibit and for sale at 1UV Gallery Studio is not included in the appointment. If the client chooses to purchase a product on exhibit for sale at 1UV Gallery Studio at the time of their appointment they will receive a 25% discount on the listed price.

Clients scheduling three or more appointments at a time will receive a 20% discount on services. Appointments may be scheduled no more than on a bi-weekly frequency. This agreement applies to all appointments made for twelve months from the day it is signed. This agreement ends on: ____/____/____.
